The review will assess and review the existing current electoral laws together with relevant sections of the Constitution, and recommend necessary changes and reforms.

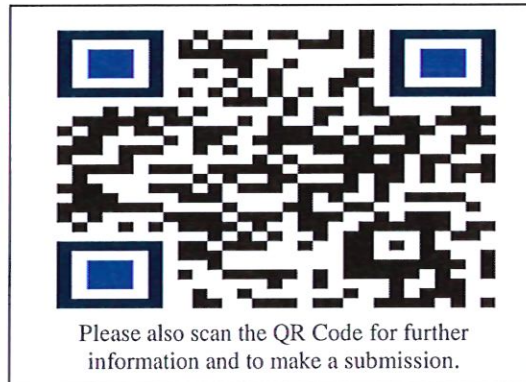
