The Fijian Elections Office (FEO) celebrated International Women's Day in a different way this year, when compared to the previous years.

In celebrating the momentous occasion, a "Food and Cleaning Supplies" drive was conducted over a two (2) week period and donations received were sent to a charitable organisation. This year the 'Homes of Hope' was identified as the partner charity for this particular drive.

The 'Homes of Hope' is the only organization of its kind in Fiji and the South Pacific that provides longterm care, trauma-informed therapies, and holistic training for girls, young women and children who are victims of or vulnerable to forced sex.

Through this drive, each Directorate were given a list of food and cleaning supplies to donate and boxes were placed at each level to allow staff to place their donations in.

The supplies included much needed food items and household cleaning items.

The items were donated to assist the home in ensuring the surrounding was clean and spotless.

Speaking at the handing over ceremony, the Homes Finance Officer Melesia Silipa thanked the FEO for its generous contributions and stated that the items collected would go a long way in assisting the Home care for the ladies and girls under their care.

Director Operations (DOps) Ms. Anaseini Senimoli, whilst handing over the boxes of donations said that the FEO was indeed privileged to support an organization that looked after and cared for some of the most vulnerable women in our society.

Items donated to the Home included food such as rice, flour, dhal, tea leaves, sugar, milk, cocoa, porridge, tin fish, chicken, fresh and frozen vegetables, fruits, carrots, onions, potatoes and garlic. Cleaning supplies included janola; dish sponges; scrubbing brush; washing powder; dishwashing detergent; disinfectant; bug spray; cockroach traps; mouse bait; rubbish bags.

International Womens Day is celebrated globally on March 8 annually to honor the movement for women's rights and to build support for achieving universal suffrage for women.

International Womens Day was first celebrated in 1911 after the second International Conference of Working Women where Clara Zetkin, a German

#### Polling Venue Assessment is crucial

An assessment of polling venues was conducted in the Yasawa Group by the Fijian Elections Office.

In undertaking this exercise, the Divisional Manager West Mr. Viliame Vuiyanuca stated that the condition of polling venues, structure and durability was assessed.

Mr. Vuiyanuca said that such exercises were important especially after a general election.

"Conducting Polling Venue Assessment (PVA) is important especially after a general election. As it is, these polling venues were used in the last general election and it is crucial that an assessment be done to ascertain the durability of these venues for the next general election," said Mr. Vuiyanuca.

Headded that during the assessment, FEO held discussions with the venue owner as well as those living nearby these polling venues.

"We had discussions with the venue owners, Turaga ni Koro, boat and hotel owners as well as those who live near these venues to get their thoughts and suggestions on whether these venues served their purpose in the last general election. We also discussed at great length how the venues could be improved before the next election." Mr. Vuiyanuca stated.

For the Western division, assessments were held at the polling venues on Yasawa I rara, Nacula, Yaqeta , Naviti, Waya and Viwa Island respectively.

"As facilitators, it is crucial that we ensure a credible election is conducted and that the FNUSA members are able to cast their votes within the specified time at the various election venues, while the election results are generated and submitted to the FNUSA in a timely manner," Mr. Wainiqolo said.

#### **EDAWG 4-Year Work Plan to guide FEO**

Those were the words of the Acting Supervisor of Elections (ASoE) Ms. Ana Mataiciwa whilst officiating at the opening of the Election Disability Access Working Group (EDAWG) 4-Year Work Plan Workshop for Inclusive Election in Suva.

Ms. Mataiciwa added that the workshop was a milestone achievement, as the participants worked together in developing the 4-Year Work Plan.

"This comprehensive 4-Year Work Plan will guide the EDAWG and the Fijian Elections Office (FEO) in conducting a more inclusive future General Elections," said Ms. Mataiciwa.

The ASoE also reiterated the recommendation highlighted in the Multinational Observers Group (MOG) Report on the continuation of the EDAWG.

"The MOG Report acknowledged the efforts of the FEO and EDAWG in promoting the participation of Fijian voters with disabilities in the electoral process and thus recommended the continuation of the EDAWG. This is something you all should be proud of," Ms. Mataiciwa stated.

Ms. Mataiciwa further encouraged the participants to openly share their thoughts and experiences and to confidently contribute to developing the work plan.

"You are not here by accident nor by chance. You are here because you have been called for such a time as this. Your contribution is valuable and you are part of the bigger picture," said the ASoE.

Ms. Mataiciwa also acknowledged and thanked the USAID Pacific Islands and the PROJECT Governance programme for organizing the workshop and ensuring election materials were made available to persons with disabilities during the 2022 General Election.

"In our recent review process, it was revealed that the FEO did not have enough collaboration with key stakeholders such as the Civil Civil Society and Media organisations."

- "Given the fact that our end users are mutual, we believe more effort must be directed at our collaborative works in enhancing voter participation and civic education," said the ASoE.
- Ms. Mataiciwa added that it was important for the FEO to collate the contribution of all stakeholders, as they would assist in drafting a Strategic Plan that is more engaging and collaborative.

"I encourage all stakeholders to maximize this opportunity by voicing your constructive criticisms with regards to our Strategic Plan and I look forward to reviewing your collective inputs at the conclusion of these discussions as well as to further work with you all in strengthening our democracy," the ASoE stated.

The consultation involved media organisations, Civil Society Organisations, Government Ministries and Departments, Statutory Authorities, Development Partners and Political Parties.
