

Know Your Election: Quiz 4- Grand Finale

Terms and Conditions

1. This Quiz competition is organized by the Fijian Elections Office [“FEO”] as part of a series of competitions to be held this year as a build up to the Know Your Election campaign for 2022.
2. The Quiz is open to everyone in Fiji except for Employees of the FEO and their immediate families.
3. To enter the Quiz, you must:
 - 3.1 Form a team of 2 members;
 - 3.2 Complete the Online Registration Form using this link

 - 3.3 Ensure that details provided on the Online Registration Form is accurate; and
 - 3.4 Ensure you are only registered in one team.
- 4 Registration must be done any time before 11.55 pm on 15 December 2021 (*Update: Due to popular demand, the quiz registration has been extended till 11.55pm on 16 December 2021*).
- 5 Upon submission of the completed online Registration Form, the Entrant automatically becomes bound by these terms and conditions.
- 6 Online Registration Forms that are incomplete or are not submitted in accordance with these terms and conditions will be deemed invalid. The FEO will not bear any responsibility.
- 7 Entry into the Quiz is free.
- 8 It is a virtual quiz. Internet will be required to participate.

- 9 There are several topics covered in the quiz including but not limited to the following: Democracy, Elections, Fijian Elections Office, The Electoral Commission, Voter Participation, Voting Systems, Voter Turnout, Electoral Laws, Political Parties and Fiji's Electoral History.
- 10 The Quiz will have 50 questions in total. Each correct answer will be worth five (5) points each. No points will be given for wrong answers.
- 11 The Quiz will take place virtually on 22 December 2021.
- 12 Teams will need to sign in and start the quiz on 22 December 2021 between 7:00pm to 7.30pm. Teams will not be able to start the quiz after 7:30pm. Once started, teams will have 90 minutes to complete the quiz.
- 13 Teams can only attempt the quiz once.
- 14 The prizes are as follows:
 - First prize: \$1000.00 cash.
 - Second prize: \$300.00 cash.
 - Third Prize: \$200.00 cash.
 - Fourth: \$150 cash.
 - Fifth: \$100 cash.
 - Consolation prizes: \$10 recharge cards x 25 (All teams that participate in the Quiz will go in the draw to win)

The prizes are non-transferrable and there will be no alternatives offered.

- 15 At the end of the Quiz, the teams to have earned the most points will win. In the event of a tie, the team to have completed the quiz in the least amount of time will be declared the winner.
- 16 In the unlikely event that no registrations are received by the closing date, the FEO may cancel the Quiz.
- 17 In the unlikely event that the registered teams do not participate in the Quiz, the prizes will not be awarded.

- 18 The winners will be notified on 22 December 2021 at the end of the Quiz.
- 19 The winners will be invited to the FEO HQ in Suva to receive the prize from the Supervisor of Elections.
- 20 Those winners who are unable to come in person, must organize with FEO on the collection of their prize within 14 days of being notified or the prize will be deemed to be forfeited
- 21 In the event of a dispute or disagreement in relation to the Quiz, the decision of the FEO will be final. No further discussion will be entered into.
- 22 The FEO reserves the right to withdraw or cancel the Quiz at any time prior to the closing date for registrations. In such a scenario, the change will be notified on the FEO website.
- 23 The FEO also reserves the right to cancel the Quiz if there is considerable reason to believe that the Quiz is being used for unlawful purposes or for purposes not intended by the FEO.
- 24 The FEO can make amendments to these terms and conditions without prior notice. Any amendments shall be notified on the FEO's website at www.feo.org.fj
- 25 Privacy: Personal details of all Entrants will be kept confidential at all times.
- 26 Right to Use Entries: By entering the Quiz, the entrants consent to the use of their full name, age and city/town to which they belong for the purposes of advertising, awareness, publicity for the FEO and promotion of the Quiz without additional compensation or permission, unless prohibited by the law. The FEO will have non-exclusive and binding right to reproduce, publish, edit and otherwise use the aforementioned information for purposes described above.
- 27 The competition and these terms and conditions will be governed by the laws of the Republic of Fiji and all and any questions or disputes will be subject to the exclusive jurisdiction of the Fiji courts.
- 28 Any violation of these terms and conditions would result in automatic disqualification.
