- 1 colored digital photograph (35 x 45mm) of the Applicant. This must be taken with a white colored background as it will be used on the Accreditation Badge.
- A copy of the certificate of registration from Media Industry Development Authority ['MIDA'].

2. Accredited Media Code of Conduct

- I will not take photographs, footage, audio or interview without the approval of the Supervisor of Elections.

1. **Costs and Funding**

All costs associated for Media Personnel and organisations to observe and report on the 2022 General Election are to be met by the Media Personnel or their employer.

2. **Visas and Immigration**

Media Personnel and organisations are to ensure that they have the correct visas and immigration clearance to enter Fiji.

3. **Accreditation Documents**

All Media Personnel and organisations, having obtained approval from MIDA, must submit this completed form and requirements as per instructions above.

4. **Observance of Media Code of Conduct**

To remain accredited, Media Personnel must conduct themselves within the Accredited Media Code of Conduct.

5. **Removal of Accreditation**

Media Personnel and organisations will have their accreditation removed if they do not comply with the Accredited Media Code of Conduct or any other legislative or administrative requirements.
